



## **ASSURANCE STATEMENT WATER WITHDRAWAL**

To: Stakeholders of Motorola Solutions, Inc.

Apex Companies LLC, (Apex) was engaged to conduct an independent limited assurance of the water withdrawal reported by Motorola Solutions, Inc. (Motorola Solutions) for the period stated below. This assurance statement applies to the related information included within the scope of work described below.

The determination of the water withdrawal is the sole responsibility of Motorola Solutions. Motorola Solutions is responsible for the preparation and fair presentation of the water withdrawal in accordance with the criteria. Apex's sole responsibility was to provide independent assurance on the accuracy of the water withdrawal reported, and on the underlying systems and processes used to collect, analyze, and review the information. Apex is responsible for expressing an opinion on the water withdrawal statement based on the assurance.

### **Boundaries of the reporting company Water Withdrawal covered by the assurance:**

- Operational Control
- Worldwide

### **Water Data assured:**

- **Total Water Withdrawal:** 66,331,683 gallons

Data and information supporting the water withdrawal assertion were in many cases historical in nature and in some cases estimated.

### **Period covered by the water withdrawal assurance:**

- January 1, 2023, to December 31, 2023

### **Criteria against which assurance was conducted:**

- CDP Guidance for Companies Reporting on Water on Behalf of Investors and Supply Chain Members (Total Water Withdrawal only)

### **Reference Standard:**

- Apex's standard procedures and guidelines for external Assurance of Sustainability Reports and International Standard on Assurance Engagements (ISAE) 3000 Revised, Assurance Engagements Other than Audits or Reviews of Historical Financial Information (effective for assurance reports dated on or after Dec. 15, 2015), issued by the International Auditing and Assurance Standards Board. A materiality threshold of  $\pm 5$  percent was used for the assurance process.

### **Level of Assurance and Qualifications:**

- Limited Assurance Level

### **Assurance Methodology:**

- Interviews with relevant personnel of Motorola Solutions;
- Review of documentary evidence produced by Motorola Solutions;
- Review of Motorola Solutions data and information systems and methodology for collection, aggregation, analysis and review of information used to determine water withdrawal; and,
- Audit of sample of data used by Motorola Solutions to determine water withdrawal.



**Assurance Opinion:**

Based on the process and procedures conducted to a limited assurance level, there is no evidence that the water withdrawal assertion shown above:

- is not materially correct and is not a fair representation of the water withdrawal data and information; and
- has not been prepared in accordance with the CDP Guidance for Companies Reporting on Water on Behalf of Investors and Supply Chain Members.

It is our opinion that Motorola Solutions has established appropriate systems for the collection, aggregation and analysis of quantitative data for determination of water withdrawal for the stated period and boundaries.
