

Motorola Solutions Facility Profile Ordinance

Purpose:

The purpose of this ordinance is to enhance safety measures and emergency response capabilities at facilities within the jurisdiction of _______ by requiring all applicants for a business license to operate to create and submit a detailed Motorola Solutions Facility profile.

Section 1: Definitions

Motorola Solutions Facility Profile: A comprehensive document created using the Smart911 Motorola Solutions Facility
feature that contains detailed information about the layout, safety measures, security protocols, emergency procedures,
and contact information of the Motorola Solutions Facility.

Section 2: Requirement for Motorola Solutions Facility Profile

- 1. All applicants seeking a business license to operate within the jurisdiction must create and submit a detailed Motorola Solutions Facility profile as part of their license application.
- 2. The Motorola Solutions Facility profile must be submitted to the relevant licensing authority for review and approval before a business license is issued.

Section 3: Contents of Motorola Solutions Facility Profile

The Motorola Solutions Facility profile must include, but is not limited to, the following information:

- 1. Layout of the venue, including entrances, exits, stages, designated areas for attendees, and floor plans of each building.
- 2. Safety measures in place, such as fire exits, emergency lighting, first aid stations, crowd control barriers, and capacity limits.
- 3. Security protocols, including procedures for handling unruly attendees, ID checks, substance prevention, and alarm contacts.
- 4. Emergency procedures for medical emergencies, fires, or other incidents, along with points of contact on site and property owner information.
- 5. Geographical boundaries including parking lots, gate access codes, and other essential details for emergency responders.
- 6. Landline phone numbers within the building for dispatcher access during emergencies.



Section 4: Compliance and Enforcement

- 1. The licensing authority will review each Motorola Solutions Facility profile to ensure compliance with this ordinance and any other relevant laws and regulations.
- 2. Failure to provide a complete and accurate Motorola Solutions Facility profile may result in the denial or revocation of a business license for the organization.

Section 5: Implementation and Effective Date

- 1. All new applicants for a business license to operate must comply with this ordinance upon its effective date.

Section 6: Communication and Training

 The licensing authority shall provide guidance and assistance to the organization on creating and submitting their Motorola Solutions Facility profiles.

Section 7: Review and Updates

- 1. Motorola Solutions Facility profiles must be reviewed and updated annually by facility operators to ensure the information remains current and accurate.
- 2. Any significant changes to the organization must be promptly reflected in the Motorola Solutions Facility profile and communicated to the licensing authority.

Section 8: Severability

If any provision of this ordinance is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.
